The meeting was called to order @ 7:04 PM.

Approval of minutes from the March 2015 meeting. Moved by: Jenn Parsons, Second, Andy Parker. All in favor.

Treasurer's report: Cash balance: \$13,083.70

Restoration Fund: \$12,424.16

We have not yet received funds from the 2014 Sandy Beach Triathlon towards the Restoration Project.

Old Business:

- Architect update - The completed plans have not been received from the project architect. He will have the bid package ready by Monday, April 27.

New Business:

- Beach Manager - Sarah and Chris Bednar will be taking over as Sandy Beach Managers for the 2015 season. Ed and Commission members will meet them to walk the beach as soon as possible.
- Morris budget update - Ed Ryle attended the Morris Board of Finance meeting. The operating funds are in the proposed Morris budget at this time. They requested that Ed submit a written request for the capital funding necessary to complete the Restoration Project. Ed will meet again with the Board to present our request for funding and to explain the project.
- Bid process - The bid process can begin once the architect has completed the package.
- Staffing - We have all the lifeguards for the upcoming season. We have one WSI and an applicant for WSI. Denise will give all the staffing information to the Bednars. They will contact staff for beach clean-up and staffing for opening on Memorial Day weekend. Denise will draft a letter to send to the applicants for the Beach Manager position.
- Season dates - Bantam Lake Ski Show: August 8 & 9.

Swim lesson sign-ups: Saturday, May 30 and Saturday, June 6 from 11:00-1:00 at the beach. Denise will write a press release and update the flyer for the schools.
