
Pursuant to CGS §7-7 the Board of Selectmen has determined that the Town Budget for the Fiscal Year Commencing July 1, 2017 shall be voted on by referendum to be held on Wednesday, September 13, 2017, 12:00 noon to 8:00 p.m. at the Morris Community Hall, 3 East Street, Morris, Connecticut for those persons eligible to vote in town meetings pursuant to CGS §7-6 on the following question:

SHALL THE TOWN BUDGET FOR THE FISCAL YEAR COMMENCING JULY 1, 2017 IN THE TOTAL AMOUNT OF \$9,530,152 BE APPROVED?

Those in favor shall vote YES. Those opposed shall vote NO.


