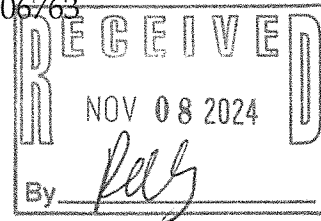

Veronica Florio made a motion to add under 7b Executive Session- Personnel Matter. William Ayles Jr seconded the motion. The motion passed unanimously.

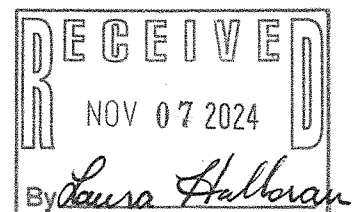
